Burlington as we know it today is rich in history and modern traditions of many First Nations and the Métis. From the Anishinaabeg to the Haudenosaunee and the Métis – our lands spanning from Lake Ontario to the Niagara Escarpment are steeped in Indigenous history.

The territory is mutually covered by the Dish with One Spoon Wampum Belt Covenant, an agreement between the Iroquois Confederacy, the Ojibway, and other allied Nations to peaceably share and care for the resources around the Great Lakes.

We acknowledge that the land on which we gather is part of the Treaty Lands and Territory of the Mississaugas of the Credit.

- In partnership with the Burlington Public Library a member of Burlington Accessibility Advisory Committee (BAAC) will participate in ReadAbility, an event at the Tansley Woods Library during Family Storytime on May 31 at 10:30am. A children's book will be read to share experiences about living with different abilities and there will be time to chat with the children after!
- The BAAC will have a table at the Accessible Sport and Art Fair being hosted by the Department of Recreation, Community & Culture at Tansley Woods Community Centre on May 31 1:00pm-4:00pm. We will use this opportunity to receive feedback, answer questions, and have discussions about accessibility in Burlington. We will also be sharing information about AccessNow, a crowd sourcing application that everyone can use to share their experiences in the community about what is accessible or if they had challenges.

We are interested in learning about your experiences with accessibility in our community! As more events and community engagement opportunities are

scheduled for the upcoming year we will share this information with the community of Burlington!

Proposed Ron Baliko Accessibility Award (name TBD?)

Burlington Accessibility Advisory Committee

1. Purpose of the Award

The **Ron Baliko Accessibility Award** recognizes individuals (or organizations?) who have demonstrated outstanding commitment to accessibility and inclusion within the City of Burlington. The award aims to celebrate initiatives that remove barriers, improve accessibility, and enhance the quality of life for individuals with disabilities.

2. Eligibility Criteria

Eligible nominees must meet the following criteria:

- Live within the municipality of Burlington.
- Demonstrate a clear commitment to accessibility through policies, programs, or physical improvements.
- Implement initiatives that go beyond compliance with accessibility laws and regulations.
- Have made a measurable impact on improving accessibility for people with disabilities.
- Show a commitment to sustainability and long-term accessibility improvements.

3. Award Categories: Ideas

The award may be given in the following categories, or include these in the descriptor of the award:

Individual:

- Community Program & Services Accessibility Award: Recognizing programs, events, or services that enhance accessibility and inclusion in the community.
- **Education and Awareness Award**: Honouring efforts to promote accessibility awareness and education within the municipality.
- **Lifetime Achievement Award**: Recognizing an individual with a long-term commitment to advancing accessibility.

Organization:

- **Built Environment Accessibility Award**: Recognizing physical improvements in public spaces, buildings, and infrastructure that enhance accessibility.
- **Digital Accessibility Award**: Recognizing accessible websites, apps, or digital content that promote inclusion.

• Employment and Workplace Accessibility Award: Honouring inclusive hiring practices and workplace accommodations for employees with disabilities.

4. Evaluation Criteria

Nominations could be evaluated based on:

- **Innovation**: How creative and unique is the approach to accessibility?
- **Impact**: How significantly has the initiative improved accessibility for individuals with disabilities?
- **Sustainability**: How well does the initiative ensure long-term accessibility improvements?
- **Community Involvement**: How effectively has the initiative engaged the community and people with disabilities in its design and implementation?
- Compliance & Beyond: Does the initiative exceed legal accessibility requirements?
- **Personal Story**: How has living with a disability impacted the nominee's call to advocacy/community involvement?

5. Nomination Process

- **Submission**: Nominations may be submitted by individuals, organizations, or government entities via an online form or paper application.
 - o See the Civic Recognition webform
- **Supporting Documentation**: Nominations must include a detailed description of the initiative, bio and background of the individual, impact statements, testimonials, and relevant images or documentation.
- **Deadline**: Nominations must be submitted by a specified deadline each year (Spring if we align with the Civic Recognition awards).
- **Selection Committee**: A diverse panel, including individuals with lived experience of disability, municipal representatives, and accessibility experts, will review nominations and select winners. Most likely the Burlington Accessibility Committee members.
- **Nomination information** will be kept confidential in accordance with the Municipal Freedom of Information and Protection of Privacy Act (MFIPPA).

6. Recognition and Benefits Ideas

Award recipients will receive:

- A certificate or plaque presented at a municipal event.
- Public recognition through municipal websites, social media, and local press.
- Potential funding or support to expand their accessibility initiatives (if applicable).
- Invitation to share their work at an annual accessibility forum or event.

7. Awards Ceremony Ideas

• Potential to collaborate with the Civic Recognition Awards.

- Should be presented by the mayor, Councillor Sharman, and/or chairs of the BAAC.
- Potential funding or support to expand their accessibility initiatives (if applicable).
- Invitation to share their work at an annual accessibility forum or event.

8. Commitment to Ongoing Accessibility

The City of Burlington will continuously evaluate and update the award criteria to reflect evolving accessibility standards, best practices, and community needs. This award serves as both recognition and encouragement for continued progress in accessibility and inclusion.

9. Next Steps

Decide:

- The scope of the award (individual/organizations).
- If the award will be presented at the Civic Recognition ceremony and by whom.
- Criteria and a possible subcommittee to evaluate nominations.
- Application/nomination process.
 - When it opens/closes
- What the award will entail?
- Collaborate with city to ensure broader reach to attract more nominees: website, social media, press(?).
- Add items as needed.
