7.1 Downtown Pay Station Upgrade Update (Stephen Camm)

7.2 Green P Licensing Update (Stephen Camm)

Barry Glazier suggested that a larger Green P be installed on Lakeshore Rd. to direct patrons to the Parking Garage. Brush is covering the current signage, Stephen will connect with RPF to have the brush removed.

Mike Wier will look at having larger 4 x 4 signage installed at the John St. & Elizabeth St. parking lot to direct patrons to 414 Locust St. parking garage.

7.3 Waterfront Garage - Elevator - Modernization (Kaylan Edgcumbe)

Phase One: Process to install new Elevator is underway. Tender award to contractor report to Council in November 2025. Project completion with elevator installed is estimated to be May 1- September 1, 2026. Old elevator will not be decommissioned until the new elevator is ready to be installed.

Phase Two: Looking to extend current BPAC elevator to the top floor of the parking garage. Looking at adding vestibules and more of a walkway to dissuade people from walking through vehicle traffic areas.

7.4 409 Brant St. Development Update (Kaylan Edgcumbe)

There will be a loss of 4 on street parking stalls in front of 409 Brant St., these parking spots will be recovered in new Sims Square parking lot.

15 spaces will be down during construction at 409 Brant St. for approx. 2 years. The spots will be left in tact until Sims Square lot 4 is ready for use.

7.5 Sims Square Parking Lot Update (Kaylan Edgcumbe)

The Sims Square parking lot is now operated by Canada wide Parking. The goal is to relocate current paid customers by 2026-2027 and be operated by the City of Burlington.

Improvements will be made to the Sims Square parking lot. It will be a more daily user friendly parking lot. About 30 spots will open up for evenings and weekends – new capacity – paid parking.

7.6 Downtown Parking Plan (Kaylan Edgcumbe)

Brian Dean noted that there have been plentiful discussions with Downtown Business's through the BDBA regarding parking and the results of the Stantec consultation. Brian Dean acknowledged that Stantec's findings are good. But noted that there should be room for lived experience in the recommendation to Council.

Kaylan noted that it is important for Downtown Business's to engage through the online survey.

Brian and Kaylan will connect to gather information regarding Downtown Business concerns.
