- Maura noted that the aging infrastructure of Burlington Hydro and the resulting issues/impacts on rural and agricultural businesses was not discussed.
- Wilma asked if the data could be separated out to show rural Burlington on its own. Rishia responded that she can do this and will send to members as well as the three rural councillors.

## **8. Delegation(s):**

8.1 Richard Lesueur spoke to Item 5.1 - Dumping/Anti-littering in the rural area and provided a brief history of the dumping issues in Ward 6 and shared a dumping audit that he completed on Oct. 25, 2025.

## **9. Regular Items:**

9.1 Dumping/Anti-littering in the rural area

- Dumping/littering in the rural area continues to be an issue and members stated the challenges and difficulty in reporting to the City and noted that there needs to be a proper process in place. Vincent noted that Councillor Galbraith was launching a communication campaign but hasn't heard an update recently. **Action:** Chair to reach out to the councillor for an update.

9.2 2026 Workplan Discussion

- Committee reviewed the draft actions identified at last month's meeting to aid in the initial implementation of the Agricultural Action Plan, and discussed how this fits into the committee's 2026 workplan. Further discussion will take place at the January meeting.
- Members expressed concern regarding the slow progress on rural issues and noted frustration with the committee's perceived lack of effectiveness in achieving positive change for the rural area.

### 9.3 Advisory Committee Recruitment update

- Jo-Anne advised that the advisory committee recruitment has been paused until next year following the municipal election. This will allow new committee terms to begin in January 2027, aligned with the incoming Council. Members whose terms were set to expire in December 2025 were asked if they would consider extending their term for one additional year to ensure continuity during this transition period. **Action** - Jo-Anne will follow up with these members.

- Jo-Anne stated that she will reach out to members to seek interest for a Christmas get together in December.
