Hearing respecting Mohammad Aminzadeh Bar Fouroush (O/A Gem Taxi)'s appeal of Business Licence Decision Notice number 2025-473383, made December 8, 2025, to refuse issuance of three Taxicab Plate Owner Licences (Plates #100, 601 and 602) under Public Vehicle By-law 20-2009.

The City's Representative, Alycia Vanderhout, Senior Law Clerk, Adam Palmieri, Manager By-law Enforcement, the Appellant, Mohammad Aminzadeh Bar Fouroush, and the Appellant's Agent Gerard P. Murphy attended the Hearing.

Mr. Murphy requested an adjournment of the matter to March 26, 2026, to give Sean Elliot, Manager of Licensing and Administration time to review documents filed by the Appellant two days before the hearing.

Ms. Vanderhout advised that the City was prepared to proceed with the hearing, but consents to the request for an adjournment for the reason provided, on the condition that the Appellant will not operate the taxicab vehicles (Plates #100, 601 and 602) until the Appeals Committee has rendered its decision on the matter.

The Appeals Committee may start to hear a matter at any time from **1:00 pm** onward. Once a matter has started it may continue to be heard after regular business hours, until such later time as determined by the Appeals Committee.

If you require an interpreter at the hearing, bring someone with you who speaks both your language and English. Your interpreter will be required to affirm that they understand your language, and they will truly interpret from that language to English to the best of their skill and understanding.

Subject: NOTICE OF LICENCE REFUSAL

Please be advised that, pursuant to the City of Burlington's Public Vehicle By-Law 20-2009 as amended, the issuance of three (3) Taxicab Plate Owners Licences (Plates #100, 601 and 602) for the above-noted business is hereby refused.

The reasons for the Licensing Administrator's opinion to this effect include the following:

9.1(a) The application is not complete or the fee payable in respect of the Licence or renewal has not been paid;

9.1(g) There are reasonable grounds to believe that the Applicant does not meet all the requirements of this By-law or any other By-law.

9.1(r) The issuance of the Licence or renewal of the Licence would be contrary to the public interest.

The Licensing Administrator is of the opinion that the licence should be refused on the grounds enumerated above. The reasons for the Licensing Administrator's opinion to this effect include the following:

The applicant failed to provide the requirements for a Licence or the renewal of Licence, namely:

A completed application accompanied with the Taxicab Owner requirements for the renewal of a Licence, completed on the forms provided by the Licensing Office.

The proposed Taxicab Vehicles fail to meet the following Taxicab Owner requirements:

The motor vehicle permits are not issued in the applicant's name by the Province of Ontario for the motor vehicle of which they are the owner.

The Ontario Standard Automobile Insurance policy does not provide that the Licensing Manager be given at least (10) days notice in writing prior to any cancellation, expiration or change in the amount of the policy.

on or before **January 7th, 2026**, stating your grounds for appeal. A non-refundable appeal fee of \$445.00 is required to be submitted with the Notice of Appeal as per the City of Burlington's Rates and Fees By-Law (payment made by e-transfer, credit cards, or cheques made payable to the City of Burlington). Please include in your Notice of Appeal any change of address, as the City Clerks Department will notify you by mail of the hearing date.

In the event that no appeal is taken, within the above prescribed period, the decision of the Manager of Licensing shall be deemed to be affirmed.
