9. Regular Items:

- 9.1 Community Trails Strategy project update - Marion Rabeau (Manager, Design & Construction), Claire Basinski (Consultant)

Claire Basinski provided a presentation (attached) and the committee asked the following questions and made the following comments:

(Q) Do the current trails fit into the new classification categories? Do the trails have the ability to shift from one classification to another? (A) The direction that the plan will take (unless an existing trail is identified for improvement or formalization) is to create a trail classification framework to determine the most appropriate trail classification which could be confirmation or aspiration. The point made about trails not being used as intended is common and due to the trails being multi-use when now there is more of a need for definition of land use, interaction, experience to create a full picture to remove the disconnect of how the trail is intended to be used and how it is actually used.

(Q) There are many trails that are undersized for the amount of traffic on them, this has increased over the last 6 years and expected to continue to increase, feedback from the public often has this conflict at the root. What is the solution for this? (A) The Major Greenway Trail classification (which would be the Centennial Path, maybe Maple Trail) would be 2 separate trails beside each other with a buffer between, one would be for higher speed users, the other for pedestrian or slower speed users. This is the recommendation that will be in the plan for this classification of trails.

(Q) Are there measures of success built into the plan? (A) Not currently part of this presentation today, but will be part of the plan. Working on what the evaluations will entail, frequency, how are we gathering data, how are we responding, update timelines.

(Q) You have mentioned that on road and intersections are out of scope for this project, will there be any connectivity when a trail intersects with a road. (A) Correct they are out of scope, we are looking to work with what the city has in place already and meant to work with existing plans and identify crossings and make recommendations.

(Q) Is there opportunity to partner with private land owners in order to connect city trails with private property destinations? (A) Yes, finding connections on Regional, Hydro and City owned lands will be investigated

and discussed when appropriate/necessary. Private lands are a little more difficult but not out of the question to try to work with private land owners to secure important connections throughout the trail network.

Comments/feedback is welcome, the team is also willing to meet with committee members or come to another meeting.
